CERTIFICATE OF ORDINANCE

I, the undersigned, do hereby certify that I am the duly appointed, qualified and acting Village Clerk of the Village of Mackinaw, Tazewell County, Illinois (the "Issuer"), and as such official I am the keeper of the records and files of its President and Board of Trustees (the "Corporate Authorities").

I do further certify the foregoing constitutes a full, true and complete excerpt from the proceedings of the regular meeting of the Corporate Authorities held on the **27th day of JUNE 2022**, insofar as same relates to the adoption of **Ordinance No. 1029**, entitled:

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID TO VILLAGE ELECTED OFFICIALS

A true, correct and complete copy of which ordinance (the "Preliminary Ordinance" or "Ordinance") as adopted at such meeting appears in the transcript of the minutes of such meeting. The Preliminary Ordinance was adopted and approved by the vote and on the date therein set forth.

I do further certify the deliberations of the Corporate Authorities on the adoption of such Preliminary Ordinance were taken openly and was on the agenda at least 48 hours before the meeting at which it was adopted, that the adoption of such ordinance was duly moved and seconded, that the vote on the adoption of such ordinance was taken openly and was preceded by a public recital of the nature of the matter being considered and such other information as would inform the public of the business being conducted, that such meeting was held at a specified time and place convenient to the public, that notice of such meeting was duly given to all of the news media requesting such notice, that such meeting was called and held in strict compliance with the provisions of the Open Meetings Act of the State of Illinois, as amended, and the Illinois Municipal Code, as amended, and that the Corporate Authorities have complied with all of the applicable provisions of such Act and such Code and their procedural rules in the adoption of such ordinance.

The pamphlet form of **Ordinance No. 1029**, including the ordinance and a cover sheet thereof, was prepared and a copy of such Ordinance was posted for public inspection in the municipal building, the Mackinaw United States Post Office, and the Mackinaw Library commencing on **JUNE 28, 2022** and continuing for at least ten days thereafter. The original ordinance was adopted by the Board of Trustees of the Village of Mackinaw at a regular meeting, attended by **FIVE** members of the Board, and approved by the President, as said Ordinance appears on file in my office and as the same is recorded in the Book of Ordinances of said Village.

ORDINANCE NO. 1029

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID TO VILLAGE ELECTED OFFICIALS.

WHEREAS, the President and Trustees of the Village of Mackinaw are elected officials; and

WHEREAS, the corporate authorities of the Village of Mackinaw believe it is in the best interest of the Village and its residents to compensation Village officials fairly for their services on behalf of the Village ; and

WHEREAS, it is necessary to establish the salary to be paid to each of the Village officials by ordinance; and

WHEREAS, salaries must be fixed by ordinance not less than one hundred eighty (180) days prior to the commencement of new terms of office.

NOW THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Village of Mackinaw, Tazewell County, Illinois, as follows:


SECTION 1: The following officers of the Village of Mackinaw shall receive the following salaries for his or her services in the amount set forth below:

1. The Village President shall receive for his or her services rendered to the Village of Mackinaw a salary of 7200.⁰⁰ per annum payable at a rate of 600.⁰⁰ per month beginning May 2025.


SECTION 2: This ordinance shall be in full force and effect from and after its passage, approval, and publication in a manner provided by law.
