I do further certify the deliberations of the Corporate Authorities on the adoption of such Preliminary Ordinance were taken openly and was on the agenda at least 48 hours before the meeting at which it was adopted, that the adoption of such ordinance was duly moved and seconded, that the vote on the adoption of such ordinance was taken openly and was preceded by a public recital of the nature of the matter being considered and such other information as would inform the public of the business being conducted, that such meeting was held at a specified time and place convenient to the public, that notice of such meeting was duly given to all of the news media requesting such notice, that such meeting was called and held in strict compliance with the provisions of the Open Meetings Act of the State of Illinois, as amended, and the Illinois Municipal Code, as amended, and that the Corporate Authorities have compiled with all of the applicable provisions of such Act and such Code and their procedural rules in the adoption of such ordinance.

The pamphlet form of *Ordinance No.1040*, including the ordinance and a cover sheet thereof, was prepared and a copy of such Ordinance was posted for public inspection in the municipal building, the Mackinaw United States Post Office, and the Mackinaw Library commencing on *January 10*, 2023 and continuing for at least ten days thereafter. The original ordinance was adopted by the Board of Trustees of the Village of Mackinaw at a regular meeting, attended by **FOUR** members of the Board, and approved by the President, as said Ordinance appears on file in my office and as the same is recorded in the Book of Ordinances of said Village.

### ORDINANCE NO. 1040

# AN ORDINANCE MAKING AMENDMENTS TO CHAPTER 78 OF THE MACKINAW MUNICIPAL CODE REGARDING NO PARKING ZONES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MACKINAW.

SECTION 1: Chapter 78 of the Village Code of the Village of Mackinaw is hereby amended in the following manner and method (additions shown in <u>underlined</u> font and deletions in <u>strikethrough</u> font):

### **Schedule I Parking Prohibited in Certain Locations**

A. It shall be unlawful to park any motor vehicle or to permit such motor vehicle to stand at any time in any of the following places: longer than 15 minutes on the west side of Main Street between 100 S Main Street and 116 S Main Street in the Village of Mackinaw, Tazewell County, Illinois. B. It shall be unlawful to park any truck having tandem axies, including but not limited to a tractor or tractor-trailer combination or to permit such truck to stand at any time in any of the following places:

C. A sign prohibiting the foregoing parking shall be erected accordingly. Further, from time to time the Chief of Police shall be authorized to post signs designating temporary no parking zones. It shall be unlawful to park any motor vehicle or to permit such motor vehicle to stand at any time in any area where signs have been posted designating such area as temporary no parking zone.

D. Penalty.

AYES: NAYS: ABSENT:

- 1. Whoever violates any provision of this schedule shall be punished by a fine of not less than \$100 and not more than \$750 for the first offense, and not less than \$200 and not more than \$750 for the second and each subsequent offense. Each day of any violation of any provision of this Chapter shall constitute a separate offense.
- 2. In lieu of the provisions of paragraph D(1) of this Chapter, person who have received a citation for a violation of this Chapter may settle said ordinance violation charge by paying to the Village Clerk of the Village of Mackinaw the sum of \$10 if paid within ten (10) days of issuance of the citation, or the sum of \$25 if paid within twenty (20) days of issuance of the citation, or the sum of \$100.00 if paid after the 20<sup>th</sup> day. Upon 30 days of nonpayment citation will be sent to the court of venue. So long as the citation is a first of second offense within the prior twelve (12) month period. No person who commits a third or subsequent violation of this Chapter in any twelve (12) month period shall be eligible to settle the ordinance violation charge pursuant to the provisions of this paragraph D(2).

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 4: Ordinance No. 513 of the Village of Mackinaw, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 513 shall remain in force and effect except as modified by this Ordinance.
