

ORDINANCE NO. 1084

AN ORDINANCE AMENDING THE VILLAGE OF MACKINAW MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 513 OF THE VILLAGE OF MACKINAW TO PROVIDE AMENDMENTS RELATING TO REGULATING SKATEBOARDS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MACKINAW:

SECTION 1: Chapter 93 of the Village Code of the Village of Mackinaw is hereby amended by adding and deleting wordage (additions shown in underlined font and deletions shown in ~~striketrough font~~) with new numbering for the section:

CHAPTER 93: SKATEBOARD, E-SCOOTER, AND E-BIKE REGULATIONS

SECTION 2: §93.03 of the Village Code of the Village of Mackinaw is hereby amended:

93.03 Skateboard Regulations

A. For the purpose of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

E-SCOOTER. An e-scooter (electric scooter) is a small, two-wheeled vehicle powered by an electric motor usually with a standing deck for the rider’s feet, handlebars for steering, rechargeable battery that powers the motor.

E-BIKE. An e-bike (electric bicycle) is a bicycle with a built-in electric motor that assists with pedaling

SKATEBOARD. A small, narrow board mounted on two axles with four wheels, designed to be ridden while standing.

- B. It shall be unlawful for any person to operate or ride on a skateboard
 - a. On any roadway in the village, except when crossing at a crosswalk.
 - b. On any sidewalk or public area within the area bounded by ~~Fast Street~~ Avenue, Main Street, Madison Street and Orchard Street.
 - c. On any public or private property where signs have been posted at the entrance or displayed prominently on the property prohibiting the use of E-Scooters, E-Bike or skateboards.
- C. It shall be unlawful for any person to operate an E-Scooter or E-Bike
 - a. On any sidewalk or public area within the area bounded by Fast Avenue, Main Street, Madison Street or Orchard Street.

Penalty, see § 10.99

SECTION 3: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 5: Ordinance No. 513 of the Village of Mackinaw, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 513 shall remain in force and effect except as modified by this Ordinance.
