**ADOPTING TAX INCREMENT ALLOCATION FINANCING FOR THE
MACKINAW TAX INCREMENT FINANCING DISTRICT**

WHEREAS, the Village of Mackinaw, Tazewell County, Illinois, (the “Village”) desires to adopt Tax Increment Allocation Financing pursuant to the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 *et. seq.* as amended, hereinafter referred to as the “Act”; and

WHEREAS, the Village has adopted and approved the Redevelopment Plan and Projects and designated a Redevelopment Project Area known as the “Mackinaw TIF District” pursuant to the provisions of the Act and has otherwise complied with all other conditions precedent required by the Act.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF THE VILLAGE OF MACKINAW, TAZEWELL COUNTY, ILLINOIS, THAT:

1. The Village of Mackinaw, Tazewell County, Illinois, hereby adopts Tax Increment Financing for: (i) the Mackinaw TIF District Redevelopment Plan and Projects as approved by Ordinance No. 1092; and (ii) the Redevelopment Project Area as designated by Ordinance No. 1093 and further described in *Exhibit A* (Legal Description) and *Exhibit B* (Boundary Map), both of which are attached hereto and made part of this Ordinance.
2. After the equalized assessed valuation of each tract of taxable real property in the Redevelopment Project Area exceeds the initial equalized assessed value of each tract of taxable real property in the Redevelopment Project Area, the ad valorem taxes, if any, arising from the levies upon real property in the Redevelopment Area by taxing districts and the rates determined in the manner provided in Section 11-74.4-9(b) of the Act each year after the effective date of this Ordinance until the Redevelopment Project costs and obligations issued in respect thereto have been paid shall be divided as follows:
 - a. That portion of taxes levied upon each taxable lot, block, tract or parcel of real property which is attributable to lower of the current equalized assessed value or the initial equalized assessed value of each such taxable lot, block, tract or parcel of real property in the Redevelopment Project Area shall be allocated to and when collected shall be paid by the County Collector to the respective affected taxing districts in the manner required by law in the absence of the adoption of tax increment allocation financing.
 - b. That portion, if any, of such taxes which is attributable to the increase in the current equalized assessed valuation of each lot, block, tract or parcel of real property in the Redevelopment Project Area over and above the lower of the current equalized assessed value or the initial equalized assessed value of each parcel of property in the Redevelopment Project Area shall be allocated to and when collected shall be paid to the municipal treasurer who shall deposit said funds in a special fund called the “Special Tax Allocation Fund” for the Redevelopment Project Area of the municipality for the purpose of paying the Redevelopment Project costs and obligations incurred in the payment thereof, pursuant to such appropriations which may be subsequently made.
3. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

4. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

MACKINAW TIF DISTRICT LEGAL DESCRIPTION

NO. 267581 AT THE TAZEWELL COUNTY RECORDER'S OFFICE; THENCE IN AN EASTERLY DIRECTION, ALONG THE SOUTH LINE OF SAID LOT AND ALONG THE SOUTH LINE OF "LOT A LOT 1" OF SAID PLAT OF SURVEY TO THE NORTHWEST CORNER OF LOT 24 OF "SECTION THREE OF MACKINAW VALLEY ESTATES", AS SHOWN ON A PLAT OF SURVEY RECORDED IN PLAT BOOK "EEE" PAGE 48 AT THE TAZEWELL COUNTY RECORDER'S OFFICE; THENCE IN A SOUTHERLY DIRECTION, ALONG THE WEST LINE OF SAID SUBDIVISION AND ALONG THE WEST LINE SECTIONS ONE AND TWO OF SAID SUBDIVISION, TO THE SOUTHWEST CORNER OF LOT 9 OF "SECTION ONE MACKINAW VALLEY ESTATES", AS RECORDED IN PLAT BOOK "CC" PAGE 249 AT THE TAZEWELL COUNTY RECORDER'S OFFICE, SAID CORNER LYING ON THE NORTH RIGHT-OF-WAY LINE OF TULIP DRIVE; THENCE IN AN EASTERLY DIRECTION, ALONG SAID NORTH RIGHT-OF-WAY LINE, TO THE INTERSECTION OF SAID NORTH RIGHT-OF-WAY LINE AND THE EAST RIGHT-OF-WAY LINE OF ORCHARD STREET EXTENDED IN A NORTHERLY DIRECTION; THENCE IN A SOUTHERLY DIRECTION, ALONG SAID EAST RIGHT-OF-WAY LINE, TO THE INTERSECTION OF SAID EAST RIGHT-OF-WAY LINE AND THE NORTH RIGHT-OF-WAY LINE OF FAST AVENUE; THENCE IN AN EASTERLY DIRECTION, ALONG SAID NORTH RIGHT-OF-WAY LINE AND SAID NORTH RIGHT-OF-WAY LINE EXTENDED, TO THE INTERSECTION OF SAID NORTH RIGHT-OF-WAY LINE EXTENDED AND THE EAST RIGHT-OF-WAY LINE OF WHITE STREET; THENCE IN A SOUTHERLY DIRECTION, ALONG SAID EAST RIGHT-OF-WAY LINE, TO THE INTERSECTION OF SAID EAST RIGHT-OF-WAY LINE AND THE NORTH RIGHT-OF-WAY LINE OF THE EAST-WEST ALLEY IN BLOCK "B6" OF "EAST ADDITION"; THENCE IN AN EASTERLY DIRECTION, ALONG THE NORTH RIGHT-OF-WAY LINE OF SAID EAST-WEST ALLEY IN SAID BLOCK "B6", BLOCK "B5" OF SAID "EAST ADDITION", BLOCK "B3" OF "EMINENCE ADDITION" AND BLOCK 1 OF "MATTHEWS ADDITION", TO THE SOUTHWEST CORNER OF LOT 2 IN SAID BLOCK 1; THENCE IN A NORTHERLY DIRECTION, ALONG THE WEST LINE OF SAID LOT 2 AND SAID WEST LINE EXTENDED, TO THE INTERSECTION OF SAID WEST LINE EXTENDED AND THE NORTH RIGHT-OF-WAY LINE OF FAST AVENUE; THENCE IN AN EASTERLY DIRECTION, ALONG SAID NORTH RIGHT-OF-WAY LINE, TO THE INTERSECTION OF SAID NORTH RIGHT-OF-WAY LINE AND THE EAST LINE OF TRACT 7, AS SHOWN ON A PLAT OF SURVEY RECORDED AS DOC.
