ORDINANCE NO. 845

AN ORDINANCE AMENDING THE VILLAGE OF MACKINAW MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 513 OF THE VILLAGE OF MACKINAW TO PROVIDE AMENDMENTS RELATING TO SEWER BILLING FOR WATER USED TO FILL SWIMMING POOLS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MACKINAW:

<u>SECTION 1:</u> Chapter 51 of the Village Code of the Village of Mackinaw is hereby amended by adding a new section, §51.196, which shall be as follows:

§51.196. ADJUSTMENT TO WASTEWATER USER RATE FOR SWIMMING POOL FILL-UPS.

- (A) Once during any calendar year, a user of the combined waterworks and wastewater system of the Village of Mackinaw may apply to receive an adjustment to the wastewater user rate ordinarily charged by the Village of Mackinaw for any water to be used to fill a qualifying swimming pool. A qualifying swimming pool is defined as a swimming pool with a total capacity of not less than three thousand (3,000) gallons.
- (B) The Village Collector is hereby authorized and directed to receive applications for said credit. Such applications shall set forth sufficient information necessary to determine the amount of water to be used to fill the swimming pool, along with such other information as may be required by the Village. The Village Water and Sewer Superintendent is hereby authorized and directed to review such applications and confirm and verify the accuracy of the information contained on those application, which review may include an inspection of the pool to be filled by the applicant.
- (C) The following limitations and conditions shall apply to this credit:
 - (1) A user of the combined waterworks and wastewater system shall only be eligible to receive this credit once per calendar year; and
 - (2) The application to the Village Collector must be submitted and approved prior to the filling of the pool.
- (D) Upon receipt of an application by the Village Collector and a review of the application to the satisfaction of the Village Water and Sewer Superintendent, and upon a determination that each of the requirements of this section have been satisfied, the Village Collector shall approve such application and give notice to the user. Only after receiving notice from the Village Collector may the applicant commence filling the pool. Upon approval of his or her application, the applicant shall receive a credit in the amount of 100% of the wastewater user rate which would ordinarily be charged for the water consumed to fill the pool.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect immediately upon its execution.

<u>SECTION 4:</u> Ordinance No. 513 of the Village of Mackinaw, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 513 shall remain in force and effect except as modified by this Ordinance.
