I, the undersigned, do hereby certify that I am the duly appointed, qualified and acting Village Clerk of the Village of Mackinaw, Tazewell County, Illinois (the "Issuer"), and as such official I am the keeper of the records and files of its President and Board of Trustees (the "Corporate Authorities").

I do further certify the foregoing constitutes a full, true and complete excerpt from the proceedings of the regular meeting of the Corporate Authorities held on the 13TH day of June 2017, insofar as same relates to the adoption of Ordinance No. 939, entitled:

AN ORDINANCE AMENDING THE VILLAGE OF MACKINAW MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 513 OF THE VILLAGE OF MACKINAW TO PROVIDE AMENDMENTS RELATING TO THE LIMITATION OF HOURS WORKED BY PART-TIME AND TEMPORARY EMPLOYEES

A true, correct and complete copy of which ordinance (the "Preliminary Ordinance" or "Ordinance") as adopted at such meeting appears in the transcript of the minutes of such meeting. The Preliminary Ordinance was adopted and approved by the vote and on the date therein set forth.

I do further certify the deliberations of the Corporate Authorities on the adoption of such Preliminary Ordinance were taken openly and was on the agenda at least 48 hours before the meeting at which it was adopted, that the adoption of such ordinance was duly moved and seconded, that the vote on the adoption of such ordinance was taken openly and was preceded by a public recital of the nature of the matter being considered and such other information as would inform the public of the business being conducted, that such meeting was held at a specified time and place convenient to the public, that notice of such meeting was duly given to all of the news media requesting such notice, that such meeting was called and held in strict compliance with the provisions of the Open Meetings Act of the State of Illinois, as amended, and the Illinois Municipal Code, as amended, and that the Corporate Authorities have compiled with all of the applicable provisions of such Act and such Code and their procedural rules in the adoption of such ordinance.

The pamphlet form of *Ordinance No.939*, including the ordinance and a cover sheet thereof, was prepared and a copy of such Ordinance was posted for public inspection in the municipal building, the Mackinaw United States Post Office, and the Mackinaw Library commencing on *JUNE 13*, 2017 and continuing for at least ten days thereafter. The original ordinance was adopted by the Board of Trustees of the Village of Mackinaw at a regular meeting, attended by **five** members of the Board, and approved by the President, as said Ordinance appears on file in my office and as the same is recorded in the Book of Ordinances of said Village.

ORDINANCE NO. 939

AN ORDINANCE AMENDING THE VILLAGE OF MACKINAW MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 513 OF THE VILLAGE OF MACKINAW TO PROVIDE AMENDMENTS RELATING TO THE LIMITATION OF HOURS WORKED BY PART-TIME AND TEMPORARY EMPLOYEES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MACKINAW:

SECTION 1: § 33.23 of the Village Code of the Village of Mackinaw is hereby amended in the following manner and method (with additions shown in underlined font and deletions in strikethrough font):

§33.23 PART TIME AND TEMPORARY EMPLOYEES.

Part time and temporary employees shall be paid a wage rate as determined by the Village Board. Part time and temporary employees are not eligible to receive benefits as the term is defined as provided for in §33.10(A). A part time employee is an employee who works less than 30 hours per week on a regular basis. A temporary employee is an employee who is employed for a definite period of time but works less than 1,000 hours in a calendar year. Temporary employees are usually individuals who are hired to work during the summer months while college and high school students are on vacation. However, temporary employees may work other periods of temporary employment at any time during the year. All such employment arrangements, be they temporary or part time, require the approval of the President and Board of Trustees of the Village. No part time employee may be enrolled by the Village of Mackinaw in the Illinois Municipal Retirement Fund without the approval of the Board of Trustees by a written resolution. The discretion to make a good faith evaluation of the hours expected for any employee to work of the Village of Mackinaw in any twelve month period, and the authority to determine whether an employee shall be enrolled in the Illinois Municipal Retirement Fund shall be solely vested in the Board of Trustees of the Village of Mackinaw.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect immediately upon its passage and publication as required by law.
