I, the undersigned, do hereby certify that I am the duly appointed, qualified and acting Village Clerk of the Village of Mackinaw, Tazewell County, Illinois (the "Issuer"), and as such official I am the keeper of the records and files of its President and Board of Trustees (the "Corporate Authorities").

I do further certify the foregoing constitutes a full, true and complete excerpt from the proceedings of the regular meeting of the Corporate Authorities held on the 23RD day of JULY 2018, insofar as same relates to the adoption of Ordinance No. 969, entitled:

AN ORDINANCE OF THE VILLAGE OF MACKINAW MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO.513 OF THE VILLAGE OF MACKIANW TO PROVIDE AMENDMENTS RELATING TO SUNDAY HOURS OF OPERATION FOR LIQUOR SALES

I do further certify the deliberations of the Corporate Authorities on the adoption of such Preliminary Ordinance were taken openly and was on the agenda at least 48 hours before the meeting at which it was adopted, that the adoption of such ordinance was duly moved and seconded, that the vote on the adoption of such ordinance was taken openly and was preceded by a public recital of the nature of the matter being considered and such other information as would inform the public of the business being conducted, that such meeting was held at a specified time and place convenient to the public, that notice of such meeting was duly given to all of the news media requesting such notice, that such meeting was called and held in strict compliance with the provisions of the Open Meetings Act of the State of Illinois, as amended, and the Illinois Municipal Code, as amended, and that the Corporate Authorities have compiled with all of the applicable provisions of such Act and such Code and their procedural rules in the adoption of such ordinance.

The pamphlet form of *Ordinance No.969*, including the ordinance and a cover sheet thereof, was prepared and a copy of such Ordinance was posted for public inspection in the municipal building, the Mackinaw United States Post Office, and the Mackinaw Library commencing on *JULY 24*, 2018 and continuing for at least ten days thereafter. The original ordinance was adopted by the Board of Trustees of the Village of Mackinaw at a regular meeting, attended by SIX members of the Board, and approved by the President, as said Ordinance appears on file in my office and as the same is recorded in the Book of Ordinances of said Village.

ORDINANCE NO. 969

AN ORDINANCE AMENDING THE VILLAGE OF MACKINAW MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 513 OF THE VILLAGE OF MACKINAW TO PROVIDE AMENDMENTS RELATING TO SUNDAY HOURS OF OPERATION

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MACKINAW.

SECTION 1: § 113.220 of the Village Code of the Village of Mackinaw is hereby amended in the following manner and method (additions shown in <u>underlined</u> font and deletions in strikethrough font):

§113.220 HOURS OF OPERATION.

- (A) It shall be unlawful for Class A licensed premise to sell or offer for sale at retail any alcoholic beverage except during the hours designated 1-3, and it shall be unlawful for Class B license premise to sell or offer for sale at retail any alcoholic beverage except during the hours designated 4-6.
 - 6. Sunday from eleven (11:00) nine (9:00) a.m. to twelve o'clock (12:00) a.m. (midnight).
- (B) Except as otherwise provided in this Section, it shall be unlawful for a Class A liquor license holder to sell or offer for sale at retail any alcoholic liquor in the village between the listed hours 1-7 and it shall be unlawful for a Class B liquor license holder to sell or offer for sale at the retail any alcoholic liquor in the village between the listed hours 8-14.
 - Twelve o'clock (12:00) a.m. (midnight) Monday and six o'clock (6:00) a.m. Monday;
 - 9. Twelve o'clock (12:00) a.m. (midnight) Tuesday and six o'clock (6:00) a.m. Tuesday;
 - Twelve o'clock (12:00) a.m. (midnight) Wednesday and six o'clock (6:00) a.m. Wednesday;
 - 11. Twelve o'clock (12:00) a.m. (midnight) Thursday and six o'clock (6:00) a.m. Thursday;
 - 12. Twelve o'clock (12:00) a.m. (midnight) Friday and six o'clock (6:00) a.m. Friday;
 - 13. Two o'clock (2:00) a.m. Saturday and six o'clock (6:00) a.m. Saturday;
 - 14. Two o'clock (2:00) a.m. Sunday and eleven o'clock (11:00) nine o'clock (9:00) a.m. Sunday;
- (H) All locations in the village that sell or offer for sale at retail any alcoholic liquor, having an appropriate Class A_license, in good standing with the State of Illinois and Local Liquor Control Commission, will be permitted to begin serving alcoholic beverages at eleven o'clock (11:00) a.m. on Sundays and eight o'clock (8:00) a.m. on other week days. All locations in the village that sell or offer for sale at retail any alcoholic liquor, having an appropriate Class B license, in good standing with the State of Illinois and Local Liquor Control Commission, will be permitted to begin selling package liquor at

eleven o'clock (11:00) nine o'clock (9:00) a.m. on Sundays and six o'clock (6:00) a.m. on other week days.

If any section or part of this Ordinance is held invalid, it shall not affect the SECTION 3: validity of the remainder of this Ordinance.

This Ordinance shall take effect 10 days after publication thereof as provided by SECTION 4: law.

Ordinance No. 513 of the Village of Mackinaw, as amended by this Ordinance, SECTION 5: shall remain in full force and effect and all previous amendments to Ordinance No. 513 shall remain in force and effect except as modified by this Ordinance.
