A permit issued to a person whose property is subject to private restrictions that prohibit keeping of hens is void.		
I acknowledge that I am aware that the ordinance allowing hens may be amended or repealed and that the owner acquires no vested rights to have or raise hens by virtue of the issuance of the permit. I understand that the keeping and handling of hens may cause health hazards and that adequate health precautions are the responsibility of the applicant.		
I understand that I must give the Mackinaw Police Chief, or other such individual or entity designated by the Village Board of the Village of Mackinaw, and the Village Office five (5) working days to make a determination to approve or deny the permit.
