VI. HAYNES ON MAIN LLC, CLASS G LIQUOR LICENSE:

A. **Beer Tent – June 15-17, 2017 (5pm-10pm Thursday, June 15, 2017 and 5pm-11pm Friday, June 16, 2017 and Saturday, June 17, 2017) Event to be Held in Haynes on Main, LLC Parking Lot:** Haynes on Main LLC has applied for a Class G liquor license for a special event (Beer Tent for Mack-Ca-Fest) to commence on June 15, 2017 through June 17, 2017. The Liquor Commission discussed the following special restrictions on the issuance of the license.

1. Limiting the hours of operation of the beer tent 5pm-10pm Thursday, June 15, 2017 and 5pm-11pm Friday, June 16, 2017 and Saturday, June 17, 2017. During this time the Commission discussed.

2. Requiring the area where alcohol will be served or consumed to be blocked off by fencing so that all patrons must enter through Haynes on Main, LLC thru a special entry.

3. Requiring at all entry points to the beer tent an ID check point and wrist bands available.
4. A copy of a verified lease regarding the parking lot area where the event will be held must be presented to the Village of Mackinaw.
5. Requiring security during all hours in which the beer tent is open, either in the form of off-duty police officers or on-duty Village of Mackinaw Police Officers, with security present at all entrances and exits of the beer tent.
6. All other stipulations previously imposed on Haynes on Main LLC for special event licenses may also apply.

Committee Member Ellis made the motion to recommend the approval of a Class G liquor license to Haynes on Main LLC; for June 15-17, 2017 and to recommend the listed restrictions on the issuance of the Class G license. This motion was seconded by Committee Member Laidig.

On a roll call, the vote was:

Final action on the conditions for the issuance of the license is vested in the Chief of Police, Deputy Chief of Police and the Local Liquor Control Commissioner, with the advice of the Village Board and the Local Liquor Control Commission.
